Children may not be dropped off before 7:30 am. No credit given for early pick up. Fees are payable in advance. Skatetown is not a licensed day care facility. Extended care is offered as a courtesy to parents. Camp starts at 9am ends at 5pm; any activities before or after camp are unstructured and include playing games and watching movies.
